O R D E R:

Bio-technology(BT) of late, has become an important source of crop improvement. BT research is progressing at an accelerated pace all over the world and needs encouragement in the State also. Government of A.P. has raised no barriers to BT experiments and research in the State till now. While the system of regulating BT research is fairly well established at Govt. of India level, the same is at very primitive stage in the State. Various scientific institutions, Universities and Bio-technology companies have been conducting basic trials (strip tests) and larger bio-safety research trials (BRL) 1 and 2 in the State, based on the approvals given by the Review Committee on Genetically Modified Crops (RCGM) and Genetic Engineering Appraisal Committee(GEAC). Standard Operating Procedures(SOPs) set up at Govt. of India level are being followed by the State agencies also. While RCGM & GEAC permitted Bio-technology trials all over the country till last year, they have now altered the method and seeking permission State Government (Agriculture Department) for conduct of GM crop field trials from this year onwards.

In view of the above circumstances, Government after careful consideration hereby constitute a Committee with the following to review the situation from time to time and also to reflect on the requests for Bio-technology trials (Institutional Strip Tests and also BRLs):
